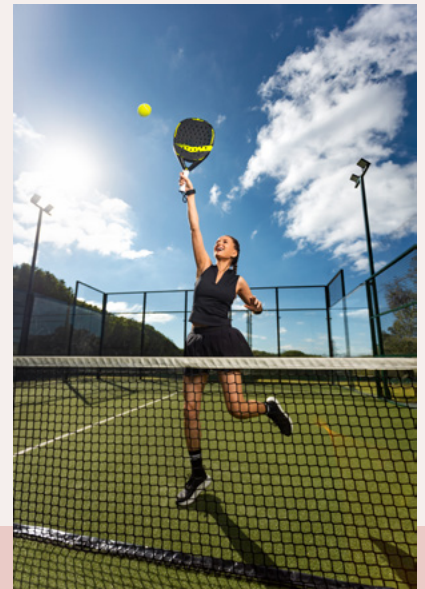

# TERMS & CONDITIONS

These Terms and Conditions apply to all private parties, corporate events, meetings and seminars held at Doddington Hall Estate.

## 1. DEFINITIONS

### In this Agreement:

- 1.1 Doddington Hall means Doddington Hall and its associated estate venues and trading entities.
- 1.2 Venue means the specific space booked by the Client, as detailed in the Booking Confirmation, including but not limited to the Coach House, the Grain Store, the Farm Shop Café and any other estate venue made available for hire.
- 1.3 Client means the individual or organisation making the booking.
- 1.4 Event means the function, meeting or gathering described in the Booking Confirmation.

## 2. CONFIRMATION OF BOOKING

### Bookings are not confirmed until Doddington Hall has received:

- 2.1 a completed and signed Booking Form or written confirmation; and
- 2.2 the required non-refundable and non-transferable deposit.
- 2.3 The Event shall only be considered confirmed once written confirmation has been issued by Doddington Hall.

## 3. DEPOSIT AND PAYMENT

- 3.1 A deposit of 25 per cent of the total Event value is required to secure the booking.
- 3.2 The balance of the total amount payable must be paid in full no later than 7 days prior to the Event, unless otherwise agreed in writing.
- 3.3 Doddington Hall reserves the right to cancel the booking if payment deadlines are not met.
- 3.4 All charges are subject to VAT at the prevailing rate. Booking documentation and quotation schedules will clearly state whether pricing is inclusive or exclusive of VAT.

## 4. CANCELLATION BY THE CLIENT

### If the Client cancels a confirmed booking:

- 4.1 the deposit is non-refundable and non-transferable;
- 4.2 where cancellation occurs within 60 days of the Event, Doddington Hall reserves the right to charge up to 100 per cent of the total contracted value; and
- 4.3 Doddington Hall shall not be obliged to credit any forfeited sums against a future booking.

## 5. ADDITIONAL CHARGES AND VARIATIONS

### The Client shall be responsible for any additional charges arising from:

- 5.1 increases in guest numbers;
- 5.2 additional food or beverages;

- 5.3 table linen, furniture or equipment hire;
- 5.4 audio-visual equipment or technical support;
- 5.5 extended use of the Venue;
- 5.6 additional staffing, security or cleaning;
- 5.7 variations to layout, timing or agreed services; or
- 5.8 any other goods or services requested before or during the Event.
- 5.9 Such additional services may be agreed verbally on the day of the Event by the Client or their authorised representative and shall be binding.
- 5.10 All additional charges will be invoiced following the Event and are payable within 7 days of the invoice, unless otherwise agreed in writing.

## 6. CANCELLATION BY DODDINGTON HALL

- 6.1 Doddington Hall reserves the right, in exceptional circumstances beyond its reasonable control, to cancel a confirmed booking.
- 6.2 In such circumstances, all monies paid will be refunded in full and no further liability shall arise.
- 6.3 Doddington Hall reserves the right to refuse any booking prior to confirmation.

## 7. GUEST NUMBERS AND FIRE REGULATIONS

- 7.1 The Client must ensure that guest numbers do not exceed the maximum permitted by fire and safety regulations for the Venue booked.

Current maximum capacities are:

- 7.2 Coach House, 180 guests;
- 7.3 Grain Store, 300 guests;
- 7.4 Farm Shop Café, 170 guests.
- 7.5 Doddington Hall reserves the right to amend these capacities in line with regulatory requirements.
- 7.6 Final catering numbers must be confirmed at least 14 days prior to the Event. No reductions in numbers will be accepted after this date and full charges will apply.

## 8. CATERING AND BAR

- 8.1 All catering within the Venue will be provided by the Doddington Catering Team unless otherwise agreed in writing.
- 8.2 Where applicable, the Venue is licensed to sell alcohol. Alcoholic beverages may only be supplied by Doddington Hall unless expressly agreed otherwise in writing.
- 8.3 If a pay bar is required, Doddington Hall will arrange and provide all necessary facilities.
- 8.4 Alcohol not purchased from Doddington Hall is strictly prohibited and may be confiscated.

# TERMS & CONDITIONS

These Terms and Conditions apply to all private parties, corporate events, meetings and seminars held at Doddington Hall Estate.

## 9. BEHAVIOUR AND CONDUCT

- 9.1 Doddington Hall reserves the right to remove from the Venue any person behaving in an abusive, unsafe or unreasonable manner.
- 9.2 The Client is responsible for the conduct of all guests, contractors and suppliers associated with the Event.

## 10. DAMAGE AND LIABILITY

- 10.1 The Client shall be responsible for any damage caused to the Venue, its furnishings, equipment, grounds or surrounding property by any act, default or neglect of the Client, its guests, contractors or suppliers.
- 10.2 The Client shall indemnify Doddington Hall for the full cost of repair, replacement or loss of business arising from such damage.

## 11. EXTERNAL SUPPLIERS

**Where the Client employs subcontractors or third parties, it is the Client's responsibility to ensure that they:**

- 11.1 are appropriately insured;
- 11.2 comply with all health and safety legislation; and
- 11.3 adhere to all Doddington Hall estate policies.
- 11.4 Doddington Hall reserves the right to request copies of risk assessments and insurance documentation.

## 12. MUSIC AND ENTERTAINMENT

- 12.1 All DJs, bands and entertainment providers must be approved in advance by Doddington Hall.
- 12.2 Live bands and DJs must adhere to estate noise restrictions.
- 12.3 All music must end by 11.30pm unless otherwise agreed in writing.
- 12.4 Guests must vacate the Venue by midnight unless otherwise agreed in writing.

## 13. USE OF VENUE

- 13.1 The Venue is strictly non-smoking.
- 13.2 No tape, drawing pins, fixings or adhesives may be used on walls, floors or fixtures without prior written approval.
- 13.3 Any signage or installations must be approved in advance.

## 14. THIRD PARTY SERVICES

- 14.1 Where Doddington Hall is requested to arrange third party services, it does so in good faith but shall not be liable for the acts, omissions or service standards of those third parties.

## 15. FORCE MAJEURE

- 15.1 Doddington Hall shall not be liable for any failure to perform its obligations where such failure arises from events beyond its reasonable control.

## 16. INSURANCE

- 16.1 Clients are strongly advised to take out appropriate Event Cancellation Insurance.
- 16.2 Doddington Hall shall not be responsible for the loss, theft or damage to personal property belonging to the Client, guests or suppliers.

## 17. DATA PROTECTION

- 17.1 Personal data provided will be processed in accordance with Doddington Hall's Privacy Policy, available on the Doddington Hall website.

## 18. VARIATIONS

- 18.1 Any variation to this Agreement must be agreed in writing and signed by both parties.

## 19. GOVERNING LAW

- 19.1 This Agreement shall be governed by and construed in accordance with the laws of England and Wales.

## 20. CONFIRMATION AND ACCEPTANCE

- 20.1 The Client confirms that final guest numbers are due 14 days prior to the Event and that the balance of the total fee payable is due 7 days prior to the Event, unless otherwise agreed in writing.
- 20.2 The undersigned, being an authorised signatory, confirms the above booking.
- 20.3 The Client confirms that they have read and understood that this Agreement is subject to these Terms and Conditions and shall become effective upon receipt by Doddington Hall of a signed copy of this Agreement.
- 20.4 The Client consents to their data being stored and used for the purpose of receiving the information, service or facilities requested through this booking.
- 20.5 This Agreement collects personal data so that Doddington Hall can communicate with the Client and provide the service, assistance or information requested. Details of how personal data is protected and managed can be found in the Doddington Hall Privacy Policy on the Doddington Hall website.
